A Message From the Superintendent

As 2014 comes to a close, it is time to once again share with our stakeholders some information about our school district. In this edition of the West Central CUSD #235 Annual Report, you will find a wealth of information about the district's financial position, our enrollment history since 2006, our students' performance on standardized tests for the 2013-2014 school year, our sports participation numbers and information about the Class of 2014. Contact information for the Board of Education members and administrators is also included.

I am pleased to be able to report that the state of District #235 remains very strong. We continue to have significant fund balances, our student's performance on standardized, state mandated achievement tests show our students performing an acceptable level, our sports participation numbers remain relatively stable and graduates from the Class of 2014 are furthering their education at about the same rate as the graduating classes that have come before them. I am very proud of the work that is being done in this district to help prepare our students for their endeavors after leaving WCHS whether it be furthering their education or starting their chosen careers.

Last year, I reported to you that our fund balances had been declining as well as our student enrollment. Today, I can report that our fund balances continue to decline but at a slower rate and that our enrollment, at least for this year, is up over the last two years. I am pleased with both of these developments.

It is hard to believe that we are in our tenth year of existence as the West Central School District. Certainly in our ten years, we have seen many changes. I often remind the staff that change is the only constant that we deal with. The same can be said of education on a national and state level. Our staff has been proactively implementing the many changes that have been put upon by the state and federal government.

I am pleased to report that our curriculum is aligned to the required Common Core Standards. We prefer to think of the new standards as Essential Skills. We are readying our students and staff for the new PARCC state tests that our students will begin taking in March of 2015. We have been and will continue working diligently to incorporate student growth into the certified teacher's evaluation process as required by the Performance Evaluation Reform Act (PERA). We continue working to develop those teaching methods that incorporate the use of technology into daily lessons as well. I am so very proud of our staff as they work to implement these and other changes into their teaching styles in order to maximize our student's chances of success.

Likewise I am proud of our Board of Education for the many hours of work that they put in helping to lead the district. Two significant projects were completed this year with the Board's approval. First, our elementary and high school building have a new source of potable drinking water. A water line was brought to the district from just south of Biggsville and the campus potable water is now supplied by the Dallas Rural Water District. We can now offer our students and staff better tasting water; water that will no longer corrode our pipes and motors and most importantly, a sufficient water supply to fight a fire should one occur. The water line was paid for with district reserve funds.

The second significant accomplishment of this year was the installation of a fiber optic network into each district building. Working in partnership with McDonough Telephone Cooperative and the Federal E-Rate system, the district now has fiber connectivity to the internet in the buildings in Stronghurst and Biggsville. This new network will allow us to make full use of the internet and technology going forward without worrying about bandwidth or connectivity issues. This project was also paid for in part with district funds. A grant from the Federal E-Rate program provided the rest of the funding.

We will continue to attempt to stay ahead of the curve so to speak with all of the changes in education that continue to come our way.

The purpose of the Annual Report is to share a lot of information with you about the great things that are happening in our district. In spite of the state's dire financial situation and its impact on us as a district, I assure you that every staff member who works in our district is committed to doing everything they can do each day to ensure that our students have personal and academic success.

Thank you for your continued support of our school district. As always, my door is open, and I encourage you to contact me with your questions or concerns. Our goal has been and will continue to be to Provide Opportunity....Expect Excellence.

BOARD OF EDUCATION Principles of School Governance

The Board will act with the following principles of school governance in mind:

- 1. The Board clarifies the district purpose: As its primary task, the Board continually defines, re-defines, and articulates district goals and objectives to answer the recurring question–who gets what benefits for how much?
- 2. The Board convenes the community: The Board engages in an ongoing two-way conversation with the entire community. The purpose of the conversation is to enable the Board to hear and understand the community's educational aspirations and desires, to serve effectively as an advocate for continuous improvement, and to inform the community of the district's performance.
- 3. The Board employs a superintendent: The Board employs one person-the superintendent-and holds that person accountable for the performance of the school district.
- 4. The Board delegates authority: The Board delegates authority to the superintendent to manage the district and provide leadership for the staff. Such authority is communicated through written policies that specify goals and objectives desired by the Board and define operating limits.
- 5. The Board monitors performance: The Board constantly monitors progress toward district goals and objectives and compliance with written Board policies.
- 6. The Board takes responsibility for itself: The Board, collectively and individually, takes full responsibility for Board activity and behavior. Board deliberations and actions are limited to Board work, not staff work.
