The Board discussed the upcoming Triple I Conference that will take place in November. The Board discussed the upcoming Elementary Playground project. The playground committee is working on final plans and were able to share posters at the PTC Fall Festival that showed students and families the equipment we hope to purchase. There was lots of excitement from the kids when they saw the pictures! The playground committee set their next meeting for Tuesday, October 28 at 1:00 pm and will focus on fundraising ideas and plans.

The Building and Grounds committee updated the Board on their current work. The committee is holding a Local Contractor Informational meeting on Wednesday, October 22 at 6:00 pm to explain the process of school construction, bidding, bonding, insurance and our upcoming types of projects. All local contractors are invited to attend. The flyer was sent out to area contractors and is available on our social media and website. Superintendent Day also informed the Board that Summer 2026 projects have been submitted to the architect to start the process and there will be a building and grounds committee meeting after those projects are ready to discuss before posting them for bids.
